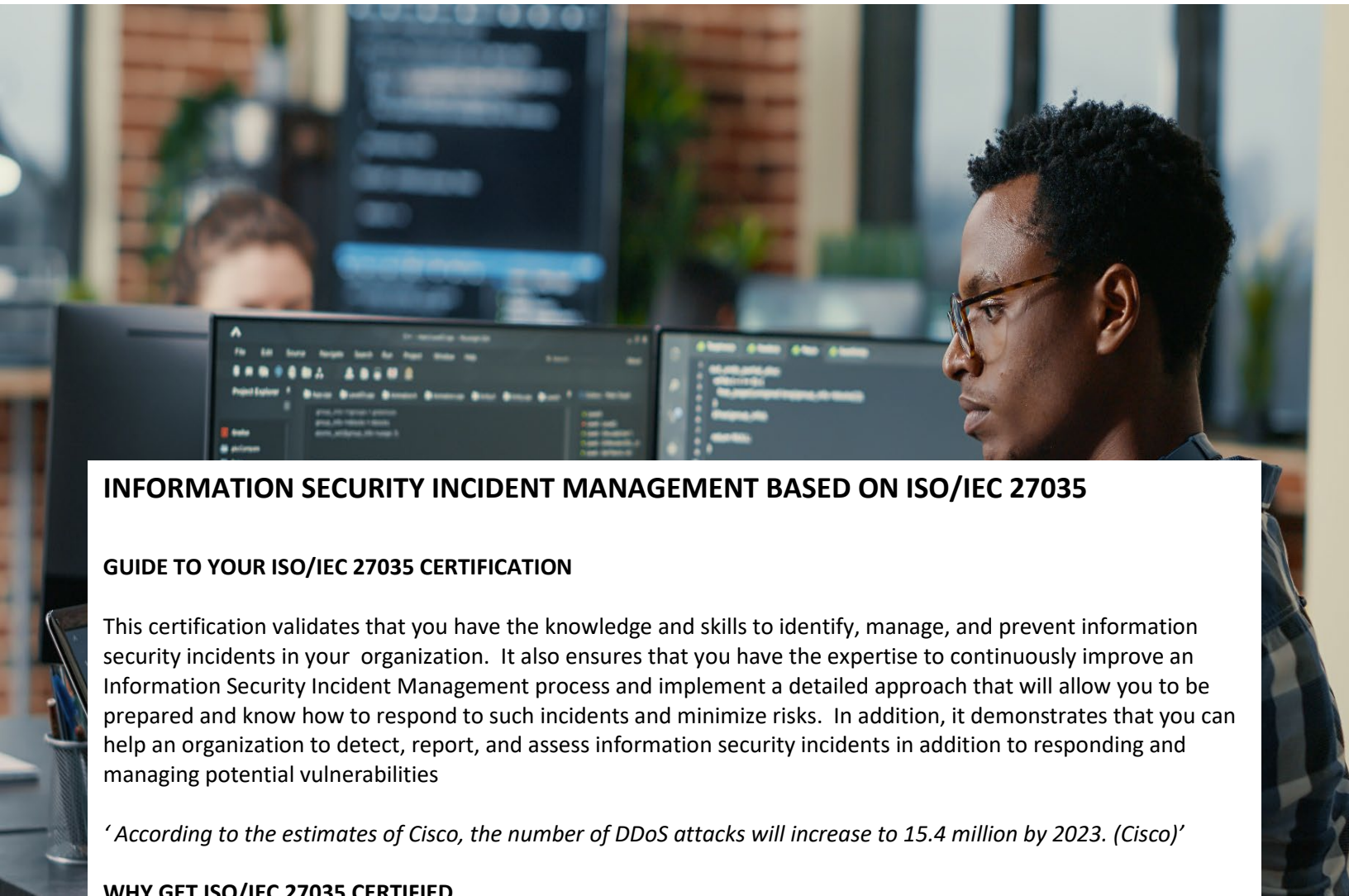

The cybersecurity maturity model certification (CMMC) is a unifying standard that is comprised of the best practices of cybersecurity of different standards. It consists of five levels of maturity which are applicable to organizations working in the Defense Industrial Base (DIB) sector. The level of maturity required for organizations depends on the information that organizations handle. The main objective of the CMMC framework is to safeguard the information that organizations working with the United States Department of Defense (DoD) handle.

A CMMC certification demonstrates that you are aware of the risks that organizations that handle sensitive information face. In addition, it demonstrates that you understand the practices and processes of the CMMC model which are essential in ensuring the protection of Federal Contract Information (FCI) and Controlled Unclassified Information (CUI). Individuals who seek to pursue a CMMC certification will gain the necessary competence to assist organizations in implementing and assessing the CMMC practices across five maturity levels that range from basic cyber hygiene practices to advanced/progressive cybersecurity practices.

### WHY GETCMMC CERTIFIED

A Juniper Research report shows that businesses will lose up to US \$5 trillion due to cybercrime by 2024. Organizations, particularly those working with governments, are often the target of cyberattacks. The federal government of the United States is heavily reliant on using information technology to increase efficiency and productivity. However, a rise in cyberattacks and data breaches affecting the operations of the government has created quite a challenge for them to ensure the protection of their information. Cyber threats continue to greatly impact the operations of the United States DoD.

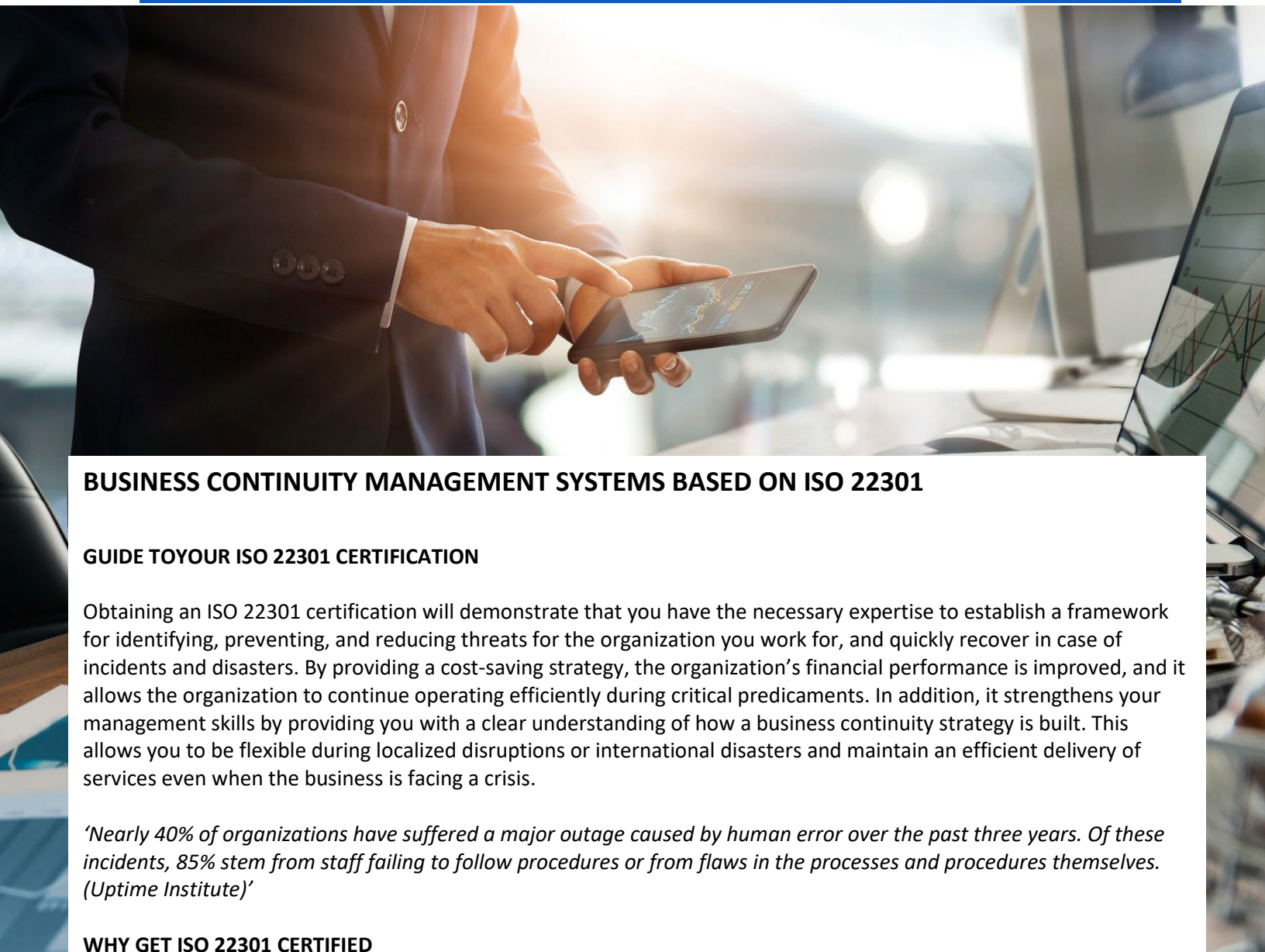
This is why the Office of the Under Secretary of Defense for Acquisition and Sustainment (OUSD (A&S)) and other stakeholders have established a cybersecurity maturity model that helps organizations improve their cybersecurity posture and ensure that their security capabilities are at the required level. The DoD released the CMMC framework, which assesses and enhances organizations' cybersecurity posture throughout the DoD contractor community. Since CMMC is a cybersecurity standard, the CMMC certification will eventually be required for all DoD contractors, including small businesses, commercial item contractors, and other suppliers. The CMMC training courses will help you acquire knowledge on CMMC domains, practices, and processes and understand how they may be applied within the DoD supply chain. In addition, CMMC training courses will help you understand the CMMC certification process and prepare you for your role in the CMMC-AB ecosystem.

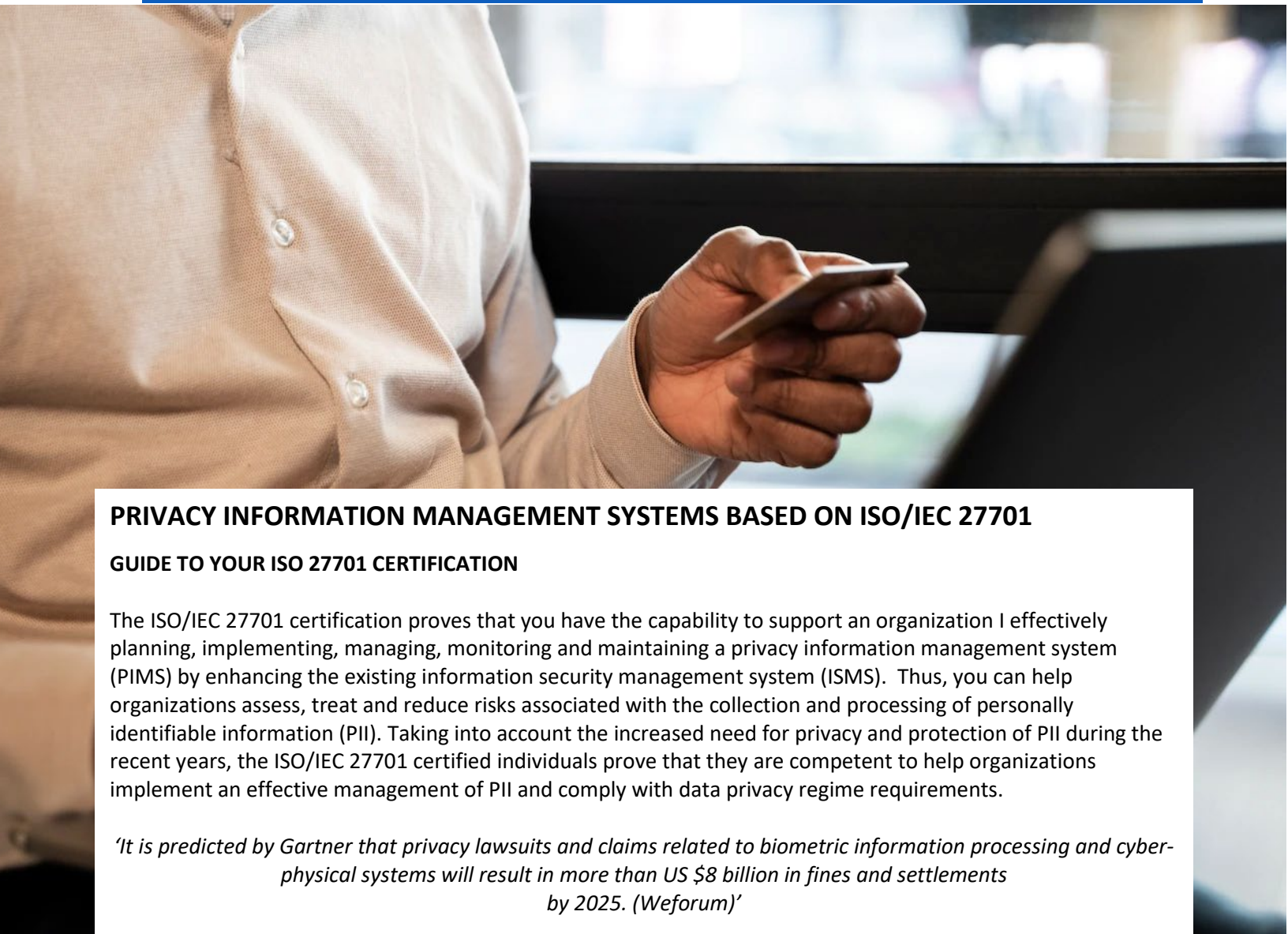

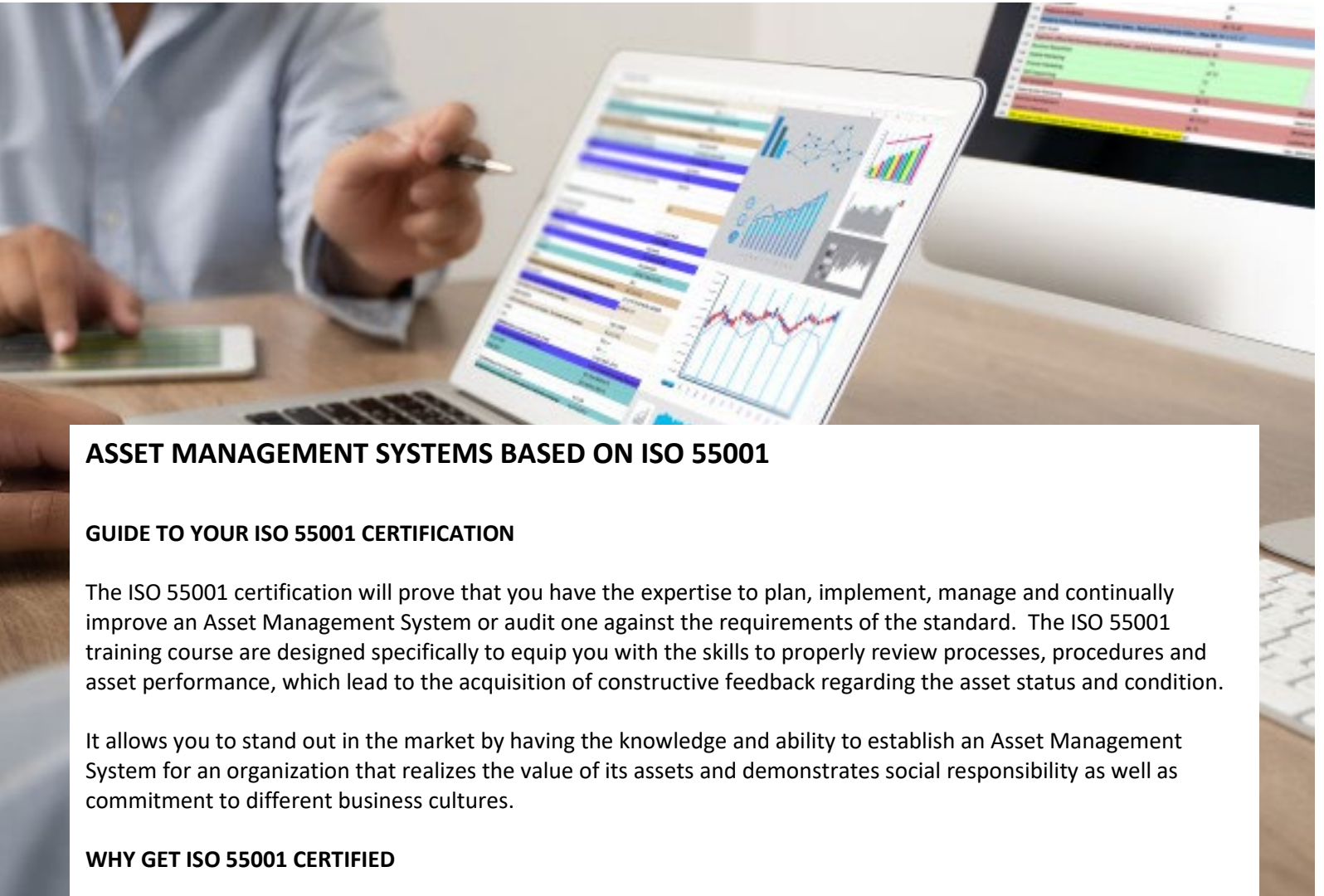
